Blackwell historic parkland dates back to the 18th century and has many beautiful trees, wildlife and green space. With the devastation that happened across the road, in what is now 'The Willows', Storey homes development, many mature trees were felled to make way for this new housing, I believe that green spaces should be kept available for people to enjoy for generations to come. Once houses have been built on this beautiful parkland, this is a decision which can never be reversed. Blackwell Grange Hotel is a listed building and I think that the whole parkland should be protected and highlighted as a beacon in Darlington. It has so much natural wildlife, it should be celebrated and not destroyed.

I have been in business in Darlington for 20 years, and one of the main attractions to this part of the North East, was the amount of green space it had and the general feel of the town. I think that this is something we should be protecting. By building more and more housing detracts from this. I sincerely hope that the historical parkland can be saved.
