Council studies have shown that there could be an extra 5437 vehicles per day using the local transport network in Whinfield alone.

The plan mentions mitigation on Barmpton Lane, Whinbush Way and Whinfield Road but does not provide any detail on how this will be done.

Barmpton Lane is the proposed main vehicular access point/route for the Skertingham Development, most of which is unsuitable in providing a main access point and no amount of mitigation will be able to improve the layout of the road to safely reduce the impact of this development.

The National Planning Policy Framework July 2021 paragraph 104 states that transport issues should be considered at the earliest stages of the plan process so that they may be addressed.

The modified plan does not go far enough in addressing the serious transport issues which will be created as a result of the Skertingham Garden Village Development.

The Darlington Northern Link Road was supposed to alleviate existing pressures on the A1150 and surrounding road network - this is now not happening, yet those pressures still exist and will be significantly added to by the Skertingham Development. This is not a sustainable development.
