• Council studies have shown that there could be an extra 5,437 vehicles per day using the local transport network in Whinfield alone. • The plan mentions mitigation on Barmpton Lane, Whinbush Way and Whinfield Road but does not provide any detail on how this will be done. • Barmpton Lane is the proposed main vehicular access point for the Skerningham Development, parts of which are unsuitable in providing a main access point and no amount of mitigation will be able to improve the layout of the road to safely reduce the impact of this development. = Barmpton Lane is already struggling and unsafe under the weight of traffic already using it. Whinfield Way, as the default access to Barmpton Lane, and an already cluttered road, would also become unusable. -The National Planning Policy Framework July 2021 para 104 says that transport issues should be considered at the earliest stages of the plan process so that they may be addressed. • The modified plan does not go far enough in addressing the transport issues which will be created as a result of the Skerningham Garden Village development. - AS above - Barmpton Lane is already struggling and unsafe under the weight of traffic already using it. Whinfield Way, as the default access to Barmpton Lane, and an already cluttered road, would also become unusable. I am a resident of Darlington who would be directly affected by this impact. • The Darlington Northern Link Road was supposed to alleviate existing pressures on the A1150 – this is now not happening, yet those pressures still exist and will be added to from the Skerningham Development. This is not sustainable development.

- This is not consistent with either the Healthy New Towns or Garden Communities principles or objectives.
